LANE END CHURCH REBUILDING.

Fifty years ago Lane End had no Church, nor Clergyman nor School; it excited the warm sympathies of the then Rector of Hambleden, the Rev. H. C. Ridley, who laboured at great personal cost to provide its inhabitants with some religious teaching. The Church was built at the cost of J. M. Elwes, Esq., who then resided at Boltor End. It was in the course of erection when the Rev. H. C. Ridley died, and was consecrated in the summer of that year. Unhappily the building was extremely bad. First, dry-rot destroyed the wood-work which had all to be renewed within 3 or 4 years. The walls were continually wet through. In 1856 a considerable sum was raised by various means to repair and embellish the Church. But this again was so badly laid out that there is little to be seen of the outlay. The beams of the roof are in such a ruinous condition that it is only waste of money to spend anything on repairing them. The only thing to be done is to pull down the existing building, and build a new Church. An Ecclesiastical District was formed in 1832 out of the 4 Parishes of Great Marlow, West Wycombe, Fingest, and Hambleden, so that Lane End is an offshoot of these four Parishes; and now in its great difficulty of finding the means of building a new Church, is obliged to look to these Parishes for parental assistance. They have engaged the services of the able Architect, Mr. John Scott, son of Sir Gilbert Scott, who is preparing plans and estimates. Lane End is itself so poor a place that it will need the utmost possible assistance from all its friends. But while preparations are making, the inhabitants of Lane End are exerting themselves to do what they can to supply their own want.

We most earnestly plead with all our readers in their behalf. If the parishes who contribute the population which attend the Church do not bestow their charity liberally towards the work, it is impossible that Lane End can do it unaided. No unnecessary expense will be incurred, but the Committee are determined that that which is now done shall be done well. The Architect thought that £3000 would be required.
